Interwoven through its chapters are two themes, often held in tension with one another: "Exploring Boundaries" and "Expanding Connections." It also speaks to reflections included in this volume on the connections between fact and value, reason and emotion, engineering practice and the social good, and, of course, between engineering and philosophy. These and other forms of boundary setting are also addressed in this volume.
